DISCUSSION

Per Section 17.68.020.E, the Planning and Zoning Hearing Officer (ZHO) may provide notice of the City's annual reviews of CUPs and respective compliance with their conditions of approval. The purpose of this notice is to keep the Council informed of activities related to the CUPs and whether enforcement action is actively taking place within the community for these conditional uses.

There are two CUPs to report on for the Council at this time:

- 2124 Desert View Drive (Child Care): CUP to allow a Home Child Care facility in the Single-Family Residence District (R1-7) zoning district
 --ZHO approved 8/14/2023
- 2) 2600 Scenic View Drive: CUP to allow for a Storage Container in excess of 20' in length in the Agricultural Residential (AR) zoning district.

--ZHO approved 8/14/2023

2124 Desert View Drive: CUP to allow a Home Child Care facility, located in the Single-Family Resident District (R1-7) zoning district

SUMMARY


At the time of original CUP application, the applicant and operator of the home childcare center provided documentation from AZDES that the facility is licensed to operate as a "Child Care Group Home" with a total capacity of 10. The effective date of the certificate is noted as November 1, 2022, and an anniversary

The operator has also confirmed that only one non-resident employee is on the premises at any given time. The second employee noted in the applicant's narrative was confirmed as a resident of the home. Furthermore, the applicant has confirmed that the day care operates from 7:00am to 4:30pm and therefore is within the standards allowed for home occupations. The family room area is generally dedicated to childcare activities and constitutes less than 20% of the gross floor area of the home and accessory structure combined. That approval was granted subject to several conditions, listed as follows:

- 1. The CUP is approved based on the owner/operator maintaining all applicable and active licensing requirements with State and other applicable agencies.
- 2. No more than one non-resident employee is allowed at the residence at any given time.
- 3. No more than 300 SF or 20% of the GFA of the residence and accessory structures shall be specifically dedicated to the day care facility.
- 4. No signage shall be installed on the property advertising the home-based business.
- 5. No play equipment shall be installed in the rear yard of the property to ensure no external evidence of the day care facility, or resulting noise, will be a nuisance for adjacent property owners.
- 6. The CUP is subject to annual review by city staff to ensure compliance with these stated conditions and will report their determination back to the Planning and Zoning Hearing Officer per Chapter 17.68.020.E of the zoning ordinance.

SITE INSPECTION SUMMARY AND PHOTOS - 7/29/2025

Marshall Larson, the City's Building Inspector, conducted a site visit on July 29, 2025, and found that all requirements of the CUP are being met. There is only one (1) employee. No signage for advertising could be seen, and all licensing was current. A photo of the home was taken and provided below:

2600 Scenic View Drive: CUP to allow a storage container in excess of 20' in length at 2600 Scenic View Drive, located in the Agricultural Residential (AR) zoning district.

SUMMARY

Based on imagery of the property and surrounding similar lots, the large ranchette residences in the Winslow Heights subdivision have plenty of land area to accommodate storage sheds, greenhouses, recreational vehicles and other accessory uses common to the neighborhood. Homes immediately adjacent to this residence have similar accessory buildings and photos were provided in the staff report as examples.


The CUP was approved subject to the following conditions:

- 1. The CUP is approved based on placement of the storage container meeting requirements of Section 17.16.050.I. which includes meeting required setbacks and obtaining any applicable permits.
- 2. The storage container shall be painted similarly to the primary residence on the property.
- The CUP is subject to annual review by city staff to ensure compliance with these stated conditions
 and will report their determination back to the Planning and Zoning Hearing Officer per Chapter
 17.68.020.E of the zoning ordinance.

SITE INSPECTION SUMMARY AND PHOTOS - 7/30/2025

While conducting the annual site inspection for the CUP, Marshall Larson found the placement of the container to be in compliance with the requirements of the CUP. The container is painted to match the surroundings and appears to meet the required setbacks.

This is the quarterly report of the City of Winslow Fire Department.

As Fire Chief, I am here to provide the highest-level service to our internal and external customers.

I will do everything in my power to protect and support the men and women under my command. I am fully committed and will be accountable to our community.

Our intent is to drive the mission of service and safety to the membership for the community that we serve. Working with the City Manager, I implemented a plan to elevate the department's level of services.

Winslow Fire Department is an "all hazards fire department" which means we are dispatched to the following types of calls:

Medical Emergency, Motor Vehicle Accidents, Hazmat Incidents, Water Rescue and Recovery, Structure Fire, Power Lines Down, and Public Lift Assist.

Community Risk Reduction (CRR) Division is a proactive approach aimed at preventing or mitigating the loss of life, property, and resources associated with life safety, fire, and other disasters within a community. The most effective risk-reduction is a combination of prevention and mitigation strategies to prevent community risks.

Winslow Fire Department Community Risk Reduction Division consists of the following: Public Education, Plan Review, Inspection of Fire Hydrants, and applying the 2018 Fire Code to inspections of new and existing buildings.

Highlights of 911 Calls.

Fire

Semi- Truck fire and Car Hauler Fire on I-40 Freeway. Winslow Fite Department, DPS and ADOT responded to both incidents. The crews handle the call by closing the freeway and fighting the fire on the I-40 with over 100 degree heat. The Officer in charge filed reports and submitted an invoice to EF Recovery to recoup funds for service provided.

Medical

Winslow Fire Department, Winslow Police Department, and Action Medical responded to several serious domestic violence 911 calls. These calls are the focus of this report due to our citizens and the crewmembers that responds to them. We are talking about behavioral heath for our first responders. As the chief it is my responsibility to preform an gap analysis on the behaviors and mindsets that must change to reduce mental health for our members.

Highlights

- Building a program to enhance the City of Winslow. Incident Command, pre plan, inspections, responder, hydrant locations, record fire and EMS training, staffing scheduler and event scheduler.
- > P25 radio is working with better coverage and clarity on the radio.
- ➤ Awarded Grant for \$422,000 to run an Incident Command. Currently reworking the grant to better serve the City of Winslow.
- > Awarded Grant for \$2,000 for 10 pails of F500 Foam.
- > Applied for two Co2 monitors through ADEQ.
- > Applied for toxic exhaust system for the apparatus bays.
- > Applied for EMS Zoll monitors though the state
- ➤ The on calls firefighters and I are repairing the water pumps in Engine 1 and 3.

Further, with the serious of the mental health of the first responders number are increasing today, which leads to suicide, alcoholism, health related problems,

it's important that we listen to these problems. I am having training to inform members of resources available.

As the fire Chief I put out a challenge to all you be sure to unplug and take a mental break.

Thank you for letting me be part of the City of Winslow and the Fire Chief.

B. Discussion and/or Action to Approve Sixth Amendment to Purchase and Sale Agreement Between City and Atlas Global Development Group, LLC to Extend the Close of Escrow from August 31, 2025 to February 28, 2026

The City Manager referred to the fifth amendment that was approved by the Council at their last meeting extending the close of escrow to August 31, 2025 and stated that Atlas is now asking for a six-month extension so they can work to resolve energy supply issues.

The City Manager and City Attorney provided information regarding details of the extension including the removal of the I-40 parcel for the proposed Tradeport hub. Atlas has 30 days to identify an alternate location either within the 1,200 acres or other properties that Atlas already owns. The city will have the option of accepting the alternate property or remove approximately 300 acres from the purchase agreement.

The City Attorney stated that since there have been several extensions, the city will want to receive updates from Atlas to make sure that progress is being made. The City Attorney also requested that if the Council is in favor of approving the extension that the motion include "to approve in final form as approved by the City Attorney."

Further discussion included clarification from Mayor Cano and the City Manager that there will be a large buffer between Southside and Coopertown and any future development on the property that is being purchased by Atlas.

Motion: Moved by Mayor Cano, seconded by Vice Mayor MacLean, to approve the sixth amendment to the Purchase and Sale Agreement Between the City and Atlas Global Development Group in final form as approved by the City Attorney. Motion passed unanimously with Mayor Cano, Vice Mayor MacLean and Councilmembers Cake, Crisp, McKee, Salazar and Tafoya voting yes.

MOTION TO ADJOURN TO EXECUTIVE SESSION

Motion: Moved by Mayor Cano, seconded by Councilmember Cake, to adjourn to executive session. Motion passed unanimously with Mayor Cano and Councilmembers Cake, Crisp, MacLean, McKee, Salazar and Tafoya voting yes. A RESOLUTION OF THE MAYOR AND COUNCIL OF THE CITY OF WINSLOW, ARIZONA, AUTHORIZING AN APPLICATION TO THE ARIZONA SMART FUND FOR A GRANT FOR DESIGN AND OTHER ENGINEERING SERVICES AND SUBMISSION PURSUANT TO TITLE 28, CHAPTER 2, ARTICLE 2, ARIZONA REVISED STATUES; AND DECLARING AN EMERGENCY.

WHEREAS, in Chapter 322 of the Laws of 2022 ("the Act"), the Arizona Legislature establishing the AZ SMART Fund and program, and authorized the State Transportation Board, among other things, to award grants to Eligible Applicants for design and other engineering services ("DOES"), grant development and submission ("GDS"), and Match for a surface transportation project for which the Applicant will submit a Federal Grant application;

WHEREAS, ARS § 28-339(Q)(1) defines "Federal grant" to mean a federal discretionary grant program administered by any federal agency for surface transportation purposes;

WHEREAS, the AZ SMART Fund Request for Grant Applications and Agreement ("RFGAA") defines surface transportation purposes to mean a road, bridge, transit or rail infrastructure project, study or plan document that is eligible for a Federal Grant;

WHEREAS, applicants for AZ SMART Fund must apply in accordance with the requirements of the Act and the RFGAA;

WHEREAS, the City of Winslow has determined that it will apply to AZ SMART for DOES for Winslow High School Road Improvements ("Project");

WHEREAS, the City of Winslow desires to submit the Project for the federal discretionary grant identified in the RFGAA;

WHEREAS, the RFGAA requires that applications include a resolution from the governing body of the Applicant stating the Project is in the best interests of the residents of the municipality or county in which the Project is or will be located and requires the resolution to state the commitment of Applicant funds, if applicable;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF WINSLOW, ARIZONA, AS FOLLOWS:

Section 1: That the City of Winslow Project described above is in the best interests of the residents of the City of Winslow.

Section 2: That the City of Winslow requests \$250,000 for DOES.

Section 3: That \$20,000.00 of cash monies of the City of Winslow are committed to the Project.

Section 4: That the City of Winslow will apply for the Federal Grant identified in the RFGAA within two years of the date an award is approved by the Board.

Section 5: That City Manager is authorized to submit and sign the RFGAA.

Section 6: WHEREAS, the immediate operation of the provisions of this Resolution is necessary for the preservation of the public peace, health and safety, and an emergency is hereby declared to exist, and this Resolution shall be in full force and effect from and after its passage by the City of Winslow.

That the Mayor and City Council, by motion, approve Ordinance No. 1438 amending chapter 2.12, section 2.12.020, chapter 2.13, section 2.13.010, and chapter 2.14, section 2.14.020 relating to the requirements that the City Council approve the personnel appointments of the City Manager to the positions of Police Chief, Fire Chief, and Director of Public Works and Facilities.

DISCUSSION

The residents of the City of Winslow adopted a City Charter and established the City of Winslow as a Council-Manager form of government. Under the Council-Manager form of government, the City Manager is the Chief Administrative Officer with the authority and responsibility to hire, supervise, and remove City personnel, offering stability, efficiency, and accountability in the administration of City affairs. The policy sections of the code requiring approval of the City Manager's appointment of personnel are in direct conflict with the Council-Manager form of government and City Charter Section 1 that defines that the City Council shall have no administrative duties. It is in the best interest of the City to permit the City Manager to appoint personnel to the positions of Police Chief, Fire Chief, and Director of the Department of Public Works and Facilities without approval of the City Council consistent with the Council-Manager form of government and City Charter adopted by Winslow.

ORDINANCE NO. 1438

AN ORDINANCE OF THE COUNCIL OF THE CITY OF WINSLOW, ARIZONA, AMENDING THE WINSLOW MUNICIPAL CODE, TITLE 2, (ADMINISTRATION) BY**AMENDING** CHAPTER 2.12 DEPARTMENT), SECTION 2.12.020 (OFFICE OF THE POLICE CHIEF CREATED-PERSONNEL), CHAPTER 2.13 (FIRE DEPARTMENT), SECTION 2.13.010 (OFFICE OF FIRE CHIEF CREATED-APPOINTMENT-TERM OF OFFICE), AND CHAPTER 2.14 (DEPARTMENT OF PUBLIC WORKS AND FACILITIES). SECTION 2.14.020 (DEPARTMENT DIRECTOR-APPOINTMENT-TERM OF OFFICE), RELATING TO THE REQUIREMENTS THAT THE CITY COUNCIL APPROVE THE PERSONNEL APPOINTMENTS OF THE CITY MANAGER TO THE POSITIONS OF POLICE CHIEF, FIRE CHIEF, AND DIRECTOR OF THE DEPARTMENT OF PUBLIC WORKS AND FACILITIES, PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES; AND PROVIDING FOR SEVERABILITY.

WHEREAS, the City Council of the City of Winslow desires to amend Title 2, Chapter 2.12 Police Department, Chapter 2.13 Fire Department, and Chapter 2.13 Department of Public Works and Facilities; and

WHEREAS, the residents of the City of Winslow, in Article I, section 2 of its Charter, established a Council-Manager form of government; and

WHEREAS, under this form of government, the City Manager is entrusted with the authority and responsibility to hire, supervise, and remove City personnel, offering stability, efficiency, and accountability in the administration of City affairs; and

WHEREAS, the City Manager is appointed by, and serves at the pleasure of, the City Council of the City of Winslow, and is charged with the efficient management of the day-to-day affairs of the City of Winslow and its departments; and

WHEREAS, the City Council has determined that it is in the best interest of the City to permit the City Manager to appoint personnel to the positions of Police Chief, Fire Chief, and Director of the Department of Public Works and Facilities without approval of the City Council consistent with the Council-Manager form of government adopted by Winslow.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF WINSLOW, ARIZONA as follows:

SECTION 1. In General.

The Winslow Municipal Code, Title 2, Administration is hereby amended to read as follows (deletions in strikeout):

Title 2 ADMINISTRATION

* * *

2.12.020 Office of Police Chief Created-Personnel

The Police Department of the City shall consist of one (1) Chief, appointed by the City Manager with approval of City Council, and such number of captains, lieutenants, sergeants and police officers as may from time to time be deemed necessary for the safety and good order of the City. The Chief of Police reports to the City Manager.

2.13.020 Office of Fire Chief Created-Appointment-Term of Office

There shall be a Fire Chief who shall be appointed by the City Manager with approval of the City Council. The Fire Chief reports to the City Manager.

* * *

2.14.020 Department Director-Appointment-Term of Office

There shall be a Director of the Department of Public Works and Facilities who shall be appointed by the City Manager with the approval of the City Council. The Director shall report to the City Manager.

* * *

SECTION 2. <u>Providing for Repeal of Conflicting Ordinances</u>.

All ordinances and parts of ordinances in conflict with the provisions of this Ordinance or any part of the Code adopted herein by reference, are hereby repealed.

SECTION 3. Providing for Severability.

If any section, subsection, sentence, clause, phrase, or portion of this Ordinance, or any part of the Code adopted herein by reference, is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions thereof.
