The meeting was called to order by Chairman Lazzarini at 4:31 p.m. The Pledge of Allegiance was recited and the invocation was given by Chairman Kenna. Roll was called and all Commissioners were present.

Discussion and/or Action to Approve Minutes – May 19, 2025

Motion: Moved by Commissioner Patton, seconded by Commissioner Coolidge, to approve the July 21, 2025 minutes as presented. Motion passed unanimously with Chairman Lazzarini and Commissioners Coolidge, Kenna, and Patton voting yes.

STATUS REPORTS

A. Report by Wiseman Aviation Which May Include Current Airport Activities and Operational Matters

Mr. Orville Wiseman reported that June was the busiest month in company history, driven by tanker base activity, with fuel sales reaching record levels. Staffing has grown to 30 employees across both locations, supported by new mechanics and inspectors, and weekly audits have been implemented to maintain consistency.

Mr. Wiseman announced that Wiseman Aviation received FAA approval for its new official call sign, "Pine Cone," and completed repainting its fifth aircraft as part of ongoing branding updates. The company has also ordered new crew cars, including a Bronco Sport for Winslow, though he emphasized the importance of ensuring vehicles are used appropriately following a recent incident.

Mr. Wiseman confirmed that preparations are in place to support the upcoming Young Eagles event on September 20 and expressed interest in helping re-establish a full Fly-In event at Winslow in the future.

B. Report by U.S. Forest Service

Mr. Enrique Pacheco was not present; therefore, no report was given.

C. Report by Airport Manager Which May Include Updates from City Regarding Airport

The Airport Manager reported no major updates. He noted that personal commitments over the past month had limited activity but confirmed ongoing coordination with city staff.

In response to Commissioner Patton's inquiry, the Airport Manager stated that Economic Development Director Jack Fitchett is expected to provide the Commission with information regarding the airport development RFP process.

The Airport Manager also reported that Jessica Lewis is no longer with the City and is no longer serving as the Recording Secretary. Cynthia Villalpando has been assigned as the new Recording Secretary. Additionally, Danielle Therio, Library Program Coordinator, has been appointed to serve as the City's liaison to the Winslow Arts Council. The Art Plane project is scheduled to appear on the Arts Council's agenda later this week.

D. Report by Airport Engineer Which May Include Airport Project Updates

The Airport Engineer, was not present; therefore, no report was given.
