Pursuant to A.R.S. 38-431.02, notice is hereby given to the members of the City Council of the City of Winslow, Arizona and to the general public that the Winslow City Council will hold a special meeting on Tuesday, May 28, 2024 at 5:00 p.m. in the main hall of the Winslow Visitor's Center, 523 West Second Street, Winslow, Arizona. Members of the Winslow City Council will attend in person.

There will not be remote options for this meeting as it will be conducted in an open house format to allow for discussion of land use maps and interaction with the public. The purpose of the Open House is to provide an opportunity for the Mayor, Council and Staff to present a draft of the City's updated General Plan to the public and provide an opportunity for the public to discuss the General Plan with City Officials in an interactive setting.

4. INTRODUCTION TO GENERAL PLAN UPDATE

The City will present an update on the status of the General Plan update to the public.

5. RECESS OF MEETING – PUBLIC VIEWING OF LAND USE MAPS

After initial presentation and discussion of the General Plan, the Mayor will recess the meeting to allow the public to view proposed land use maps at stations located throughout the room. Council members will be stationed at different map locations to listen to public comments. Members of the public are encouraged to view maps and share feedback.

6. RECONVENE MEETING – COUNCIL DISCUSSION OF LAND USE MAP FOR GENERAL PLAN

The Mayor will reconvene the session after the public have had an opportunity to view different map stations and provide comments to allow Council discussion and deliberation of public comments and feedback among Councilmembers.

NOTE: The Council will open in a special meeting but recess to allow an open house discussion of the land use maps. Comments shared can then be discussed with the entire Council before adjournment of the meeting.

*The Open Meeting Law does apply to this meeting which means that the City Council will be prohibited from discussion of matters **not** included on the agenda. However, any matters presented by the public but not set forth on this agenda may be included in a future City Council agenda. No action will be taken at this meeting.*

7. ADJOURNMENT

The City Council reserves the right to move into executive session for legal advice under authority of A.R.S. 38-431.03(A)(3) on any of the above agenda items. Meetings of the City Council are audio and/or video recorded, and, as a result, proceedings in which children are present may be subject to such recording. Parents in order to exercise their rights may either file written consent with the City Clerk to such recording, or take personal action to ensure that their child or children are not present when a recording may be made. If a child is present at the time a recording is made, the City will assume that the rights afforded parents pursuant to A.R.S. 1-602.A.9 have been waived.
